I understand and acknowledge that on rare occasions an emergency may develop which necessitates the administration of medical care, dental care, hospitalization or surgery to my child. PART C – SAFETY AND LIABILITY

Acknowledgement of Risk: I voluntarily choose to allow my child to attend the Club and understand the risks involved. I recognize that the Club and its activities may involve risk of injury to my child and I agree to accept any and all risks associated with it, including, but not limited to, property damage or loss, minor or severe bodily injury and death.

Furthermore, I recognize that my child’s participation in the Club involves activities incidental thereto, including, but not limited to, travel to/from the Club, limited availability of medical aid and the possible reckless conduct of other children. I voluntarily allow my child to participate in the Club fully aware of the risks involved. I hereby agree to accept any and all inherent risks of property damage, bodily injury or death to my child.

Hold Harmless: In consideration for allowing my child to participate in the Club and to the fullest extent permitted by law, I agree to hold harmless DigiPen, its trustees, officers, directors, employees, agents, volunteers and assigns from and against all claims arising out of or resulting from my child’s participation in the Club. “Claim” as used in this agreement means and financial loss, claim, suit, action, damage or expense, including but not limited to attorney’s fees, attributable to bodily injury, sickness, disease or death or injury to or destruction of tangible property including loss of use resulting therefrom. In addition, I hereby voluntarily hold harmless DigiPen, its trustees, officers, directors, employees, agents, volunteers and assigns from any and all claims, both present and future, that may be made by my child, me, my family, estate, heirs or assigns.

Attendance: Student agrees that he/she will cooperate with DigiPen by notifying the administration office in advance if he/she cannot attend a class. Student agrees to provide contact information, including, but not limited to, his/her local address and telephone number to DigiPen’s administration office upon arrival in Redmond, Washington. DigiPen is not responsible for providing any supervision while the Student is outside of the school premises or while outside of scheduled class times.

Medical, Dental, Health and Insurance Responsibilities: I understand and acknowledge that DigiPen will not assume responsibility for determining the medical, dental or health condition of my child. I consulted with a medical doctor and/or dentist, as I deemed necessary, with regards to my child’s individual medical or dental issues or needs, and find my child physically and mentally fit to participate in the Club. If my child requires medical, dental or hospital services while attending the Club, I know that DigiPen cannot and does not assume legal responsibility for payment of such costs. Therefore, I assure DigiPen that I assume all risk and responsibility therefore and that my child has the necessary insurance to meet any and all needs for payment of these services while participating in the Club.

Code of Conduct: Student agrees to abide by DigiPen’s Student Rules & Regulations attached hereto while attending the Club as well as staff instructions. The student understands that violation of any of the rules and regulations are grounds for immediate dismissal, without refund, and may subject the violator to prosecution.

Authorized Drop-off/Pick-up: Parents/guardians of students aged 13 and under will be required to sign in and out their student. If a person other than the parent or guardian is to pick up the student, advance written approval by the parent/guardian must be provided to DigiPen.

Late Pick-up: Students are expected to be picked up no later than the end of class at 12:00 p.m.

Permission to Use Photography or Likeness: I hereby give my permission to DigiPen to use my child’s photographic image, child’s comments from survey’s in whole or in part, for DigiPen’s marketing activities at the sole discretion of DigiPen. DigiPen will not allow the production of any student work that makes a direct or indirect reference to any of the following material/subjects and contains:

- Religious content or symbols
- Pornographic material
- Sexual and Nudity content
- Illegal substances
- References to racism or hate crimes
- References that demeans any group of society

Students who complete their projects will be given an electronic copy of their projects.

Students are not permitted to utilize any work produced at DigiPen Institute of Technology to receive any financial compensation for their work.
